

General Regulations for Visitors

Fiera di Vicenza S.p.A. has adopted the following General Regulations for Visitors in order to regulate the rules of behaviour of Visitors to the Fiera di Vicenza S.p.A.'s Headquarters upon:

- registration at the appropriate desk located at the entrances of Fiera di Vicenza S.p.A.;
- online pre-registration on the Fiera di Vicenza S.p.A.'s websites.

These rules are addressed to all the Visitors participating in the Fairs and/or Events organized or hosted by Fiera di Vicenza S.p.A..

Signing this document commits the Visitor to comply with the regulations contained therein.

PROHIBITED CONDUCT

Sale of products within the Fiera di Vicenza S.p.A.'s Headquarters

The sale of products within the Fiera di Vicenza S.p.A.'s Headquarters is strictly prohibited. In the event of a breach of this rule, Fiera di Vicenza S.p.A. will be free to avail themselves of the intervention of the Public Safety Authorities that will take appropriate measures against the person responsible for the said violation. Fiera di Vicenza S.p.A. will have the right to ask for the restitution of the entrance ticket issued to the Visitor for access to Fiera di Vicenza S.p.A.'s Headquarters.

Distribution and/or dissemination of promotional or advertising materials inside the Fiera di Vicenza S.p.A.'s Headquarters

Distribution and/or dissemination of promotional or advertising materials within the Fiera di Vicenza S.p.A.'s Headquarters is prohibited. Visitors found carrying out this activity will have their entrance ticket, valid for free circulation within the Fiera di Vicenza S.p.A.'s Headquarters, confiscated immediately.

Photographs/Videos

Visitors are expressly forbidden from taking photos and making videos within the Fiera di Vicenza S.p.A.'s Headquarters, unless they have express permission issued by the General Management of Fiera di Vicenza S.p.A.. The ban includes photographs and videos made or taken with any type of equipment (smart phones, tablets, digital video recorders, cameras, etc.), as well as drawings and audio recordings. In the event of such a breach, Fiera di Vicenza S.p.A. reserves the right to protect, before any competent body, copyright and other related rights.

Visitors are also informed that Fiera di Vicenza S.p.A., will personally or via professionals specifically appointed for this purpose, take photographs and/or film video material to document the event on its own website, in publications connected to Fiera di Vicenza S.p.A., and also using other computerised, hard copy and digital formats. Should you wish not to be photographed and/or filmed, please inform the operator, who will be identifiable by special pass.

Smoking ban

Smoking is strictly forbidden within the Fiera di Vicenza S.p.A.'s Headquarters; the violation of this regulation will be punished pursuant to Article 51 of Law 3/2003, published in the Official Gazette on 10 January 2005, with a minimum fine of € 27.50 and a maximum fine of € 275.00. It should be noted that, in compliance with the above-mentioned law, the above-mentioned sanction is doubled if the breach is committed in the presence of a pregnant woman, infants or children up to 12 years of age.

Special smoking areas will be made available within the Fiera di Vicenza S.p.A.'s Headquarters.

Animals

It is forbidden to bring dogs or any kind of animal to the Fiera di Vicenza S.p.A.'s Headquarters, with the exception of guide dogs.

VISITOR QUALIFICATION AND ENTRANCE TICKET



FIERA DI VICENZA

- All Visitors, at the time of registration, must provide evidence of their identity and occupation. In case of misrepresentation, the person concerned will be punishable in accordance with the law.
- Entrance Ticket includes one day of admission.
- Leaving the Fairground entails the impossibility of getting back inside, unless another Entrance Ticket is purchased.
- Once the Entrance Ticket is validated, no refunds will be issued (in compliance with the Italian Presidential Decree art. 74 DPR n. 633/1972). The Entrance Ticket must be preserved until the final exit of the Fairground and must be exhibited upon request.
- All Visitors who qualify for reduced Entrance Ticket price must exhibit a valid ID Card issued by a competent Authority and proving their activity.

RESPONSIBILITY

Fiera di Vicenza S.p.A. refuses any responsibility for:

- Damage to things and/or injury to people, inside the Fiera di Vicenza S.p.A.'s Headquarters, except where the damage/harm is attributable to the exclusive responsibility of Fiera di Vicenza S.p.A.;
- False and/or deceptive information conveyed through promotional or advertising materials distributed by third parties not authorized by the General Management of Fiera di Vicenza S.p.A..

Fiera di Vicenza S.p.A. reserves the right to cancel and/or reprogram Events, and/or Fairs in their calendar.

Should an Event and/or Fair be cancelled and/or reprogrammed, Fiera di Vicenza S.p.A. has the right to decide whether to refund or not tickets already purchased by Visitors.

In case of refund of entrance tickets, the refund will be made in accordance with the terms and conditions established by Fiera di Vicenza S.p.A..

These General Regulations for Visitors have been drawn up in accordance with Italian Legislation, to which reference must be made for the interpretation of the norms in these Regulations.

Fiera di Vicenza S.p.A. reserves the right to change at any time the General Regulations for Visitors. An updated copy of the Regulations will be published on all the Fiera di Vicenza S.p.A.'s websites and will be effective immediately, from the time of issue.
