### RINK REGULATIONS

#### THE FOLLOWING IS COMPULSORY IN ORDER TO ACCESS THE ICE SCATING RINK

- Purchase the rink entrance ticket at the on-site ticket office and collect your skates from the box provided;
- Hand over an identification document to collect the skates;
- Maintain correct and polite behaviour while on the rink and in the attraction area in order to guarantee your own safety and that of other skaters;
- Scrupulously observe all indications and prohibitions of these regulations.

These regulations are binding for all skaters and are considered accepted at the time of entering the ice rink.

Minors up to the age of 11 may only enter the rink if accompanied by, and under the responsibility of, an accompanying adult.

Unaccompanied minors over the age of 11 may enter the rink on presentation of a release form signed by a parent or guardian, which can be downloaded from La Biennale di Venezia website at [labiennale.org](http://labiennale.org)

Before entering the track, please give priority to those who are inside and intend to leave.

It is requested that you always follow the instructions given by the track control and management operators on site. In the event of an emergency, follow the instructions that will be communicated by the operators or via an acoustic message.

#### THE FOLLOWING IS STRICTLY FORBIDDEN

- Entering the rink without properly wearing skates;
- Entering the rink without wearing gloves;
- Playing or standing at the entrance to the rink;
- Skating in the opposite direction to the conventional clockwise direction;
- Sitting on and/or climbing over the rink balustrade;
- Skating in an excessively fast or disorderly manner;
- Swapping skates between skaters;
- Using hockey sticks or selfie sticks;
- Walking with skates outside the rink;
- Digging into the ice of the rink with skates;
- Smoking inside the rink;
- Entering the rink with food or drink;



- Throwing any objects or waste into the rink;
- Entering or leaving the rink with a run-up;
- Grabbing or shoving neighbouring skaters;
- Performing sporting evolutions and group games without authorisation from La Biennale di Venezia;
- Keeping dangerous or blunt objects in one's pocket;
- Bringing in pushchairs, bulky objects, umbrellas or sticks;
- Bringing in dogs or other animals;

#### **LA BIENNALE DI VENEZIA DECLINES ALL RESPONSIBILITY FOR THE FOLLOWING**

- Theft of objects left unattended;
- Injuries resulting from skating or other causes;
- Suspension of use of the rink for technical reasons or force majeure;

#### **LA BIENNALE DI VENEZIA RESERVES THE RIGHT TO THE FOLLOWING**

- Refuse access to, or remove from the track, any persons who have not complied with the above prohibitions and/or have behaved improperly;
- Have the runway cleared when deemed necessary.

#### **N.B.**

**Access to the rink presupposes reading and accepting all the points defined in the regulations. Failure to comply with the regulations may entitle La Biennale di Venezia to demand the immediate leaving of the space and compensation for any damage caused by the user to property and persons.**
