

COVID-19 PREVENTION MEASURES FOR VISITORS IN TRADE EXHIBITIONS



Roma, 1 Dicembre 2021

Important information to prevent Covid-19 infection Health and Safety Guidelines

The following are organizational and operational indications aimed at increasing the effectiveness of the precautions and measures of containment taken to combat the COVID-19 epidemic, during the Exhibition named. The measures introduced follow the logic of the precaution and implement the prescriptions of the Legislator, and the prescriptions of the Health Authority with the aim of safeguarding the health, safety, and well-being of all those who visit the event.

ALL VISITORS ENTERING THE EXHIBITION PREMISES ARE REQUIRED TO COMPLY WITH THE FOLLOWING OBLIGATIONS WHICH THEY INTEGRALLY ACCEPT:

1. Obligation to stay at home in case their temperature exceeds $37.5 \degree$ C, or in presence of other symptoms of possible flu; and not to enter the exhibition in case of dangerous conditions, including symptoms of flu, fever, provenance from areas at risk, or in contact with people positive to the virus in the previous 14 days, and in all cases where the Authority's measures require that the family doctor and the Health Authority are informed, besides the obligation to stay at home.

2. Obligation to comply with all the Rules and Regulations set out by the relevant Authorities and/or by the Organizers of the Exhibition regarding the access, and in particular:

- undergo body temperature check before entry;
- wear a mask for the entire stay at the exhibition center;
- keep distance from others at least 1 meter;
- avoid crowds within the exhibition venue;
- observe the rules of hand hygiene and behave correctly in terms of hygiene.

3. Obligation to timely and responsibly inform the Organizers of the Exhibition (office in the area) and/or the recognizable security personnel located in the exhibition area of the presence of any flu symptoms incurred during the visit to the Exhibition, taking care to keep adequate distance from the other people present.

Visitors' responsibility

The measures implemented by Fiera Roma S.r.l. in response to the Covid-19 pandemic, have the scope of protecting the safety and well-being of all visitors, and of anyone who accesses the Exhibition center. It is therefore in everyone's interest to respect the safety measures that have been adopted. Fiera Roma S.r.l. reserves the right to expel from the venue any person whose behavior does not comply with these safety measures.

In all hallways of the pavilions and in the common areas of the Exhibition, indications to respect the physical distancing have been placed. Keeping a distance of at least 1 meter is an individual responsibility of each visitor and pertains to whoever is inside the Exhibition venue.

Self-certification of good health

On the days of access to the Exhibition and its appurtenances, anyone who accesses the above, implicitly and automatically self-certifies that, on that precise day and time of visit, the person is in good health, has no flu symptoms, and has not been in close contact with someone with confirmed case of Covid 19 virus, in the 14 days prior to the visit and entry to the Exhibition.

Access to the Venue and permanence within the Halls of the Exhibition

The access to the Exhibition is strictly consented to those in possession of the Green COVID certification or EU digital COVID certificate, or similar international qualification recognized in Italy to be shown from smartphone or in paper format, either in Italian or English. This certification is due to:

- Anti-SARS-CoV-2 vaccination:
 - after 1st dose: certificate will be issued automatically by the National Health Authorities (DGC system) 12 days after the vaccination, it will be valid for 15 days and expires on the date for the 2nd dose.
 - after 2nd or any additional booster dose: certificate will be issued automatically by the National Health Authorities (DGC system) within 24/48 hours from the vaccination and will be valid for 9 month.
 - Negative result of a molecular test (carried out in the 72 hours prior to the date of entry to the venue) or an antigen test (carried out in the 48 hours prior to the date of entry to the venue).
 - Approved complete recovery after SARS-CoV-2 infection, (valid 180 days from the date of the first positive real-time RT-PCR test).

Besides for children under the age of 12, for those who cannot be vaccinated for medical reasons the Green COVID certification is not required. The exemption from vaccination must be proved by a medical certificate accepted according to the Italian Health Authorities.

Restrictions may differ on short notice by governmental decree please check the last update before attending.

Any check of the Green COVID certification will be carried out, **exclusively**, by the official app "Verifica C19" which can be downloaded on tablet computers with a C-Mobile system or on mobile phones, pending the issue of an updated version or the installation of a specific software. For this reason no other certificate will be accepted.

The Organizer/s of the Exhibition will have the right to check the above documentation either at the first access to the venue or during the event, through their staff who may also request the presentation of an identity document. The person who enters the halls of the Exhibition is individually responsible for what is indicated in the pre-registration form and/or in the card/ticket/entry accreditation. False statements provided to the Organizers of the Exhibition regarding the COVID Green Certification are given under the direct and exclusive responsibility of the Declarant who accesses the Exhibition.

Visitor's access to the venue is provided in two ways: by booking the visit according to the preferred days and times indicated on the website of the Exhibition (pre-registered visitor mode being strongly recommended to avoid crowds at the entrance) or by registration made on site, to be effected at dedicated different reception desk. According to this mode, the Visitor will be admitted only if the maximum capacity allowed inside the exhibition hall has not already been reached.

Anyone who enters the venue guarantees that they have read and understood the above described safety and hygiene rules, that they accept them entirely and will follow these scrupulously.

At the entrance of the venue and in other points of the pavilion there are special signs detailing information on the prevention, health and safety measures relating to Covid-19, both in Italian and in English. These will be available for consultation of visitors, exhibitors and of anyone entering the the halls. Recognizable dedicated staff will also be inside the pavilions, in charge of monitoring and promoting compliance with the necessary prevention measures, although appealing to the sense of responsibility of the visitors.

Various columns with hand hygiene products will also be provided, for exhibitors and visitors, in several points of the exhibition area, which all can freely make use of. The use of a mask is mandatory to access the venue and for the entire period of stay within the Exhibition area. The removal of the mask is permitted exclusively, and to a limited extent, during the consumption of any food and/or drink inside the stand and in the bar area, always maintaining a safety distance of 1 meter.

In the conference rooms of the Exhibition, the occupancy of seats is guaranteed to favor the minimum distancing of at least 2 meters, a spacing that must be observed by all participants in the conferences of the Exhibition.

Risk assumption

The security measures introduced at the Exhibition are intended to minimize the risk of contracting Covid-19 virus, however this risk cannot be completely eliminated. Therefore, anyone visiting the Exhibition acknowledges that the visit is at their own personal risk, thus relieving Fiera Roma s.r.l. and the Organizers from any responsibility in this regard.

Temperature over 37,5°C

The body temperature check will be effected at the entrance of the venue. In case of body temperature exceeding 37.5° C, visitors, as well as any person wanting to access the exhibition, will be invited to return home, and to contact the family doctor.

Privacy

The processing of the data provided will take place in full compliance with fundamental freedoms and in compliance with the provisions contained in Legislative Decree 30.6.2003 n. 196 and in the EU Regulation no. 2016/679, always adopting principles inspired by correctness, lawfulness, and transparency, and only for the purpose of protecting the health of the people present at the Exhibition, and in order to guarantee the protection and confidentiality of the data. The data collected will not be disclosed or disclosed to third parties outside the specific regulatory provisions and will not be transferred abroad. No personal data acquired in relation to real-time temperature detection will be stored if it does not exceed the set threshold.

Otherwise, the action of the Data Controller, Fiera Roma Srl, will be limited to the recording of the name of the Guest, and the identification code of the entrance ticket, as a documental information of the reasons that impeded the access to the exhibition, retaining these for the subsequent 14 days, after such term the data will be canceled.
